LOCAL RULES AND REGULATIONS

Item 1 MINIMUM BATCH

Petroleum Products may be tendered for transportation in quantities of not less than 15,000 barrels, with a minimum of 5,000 barrels of the same quality and characteristics for any one commodity from one Consignor consigned to one Consignee, to be offered for shipment in Shipper's tanks and accepted by the Carrier at the inlet to Carrier's Amarillo station through Shipper's connections.

The following is an exception to Item 70, Acceptance of Petroleum Products, in F.E.R.C. No. 76.1.0 and reissues thereof.

Item 2 - EXCEPTION TO ITEM 70 ACCEPTANCE OF PETROLEUM PRODUCTS
